Qualified Charitable Distributions help you give wisely. Our team is here to help guide you through the tax advantages and other benefits of a Qualified Charitable Distribution (“QCD”) as part of your IRA’s annual Required Minimum Distribution.

Typically, Required Minimum Distributions are taxed like any other form of income. QCDs, however, allow donors like you to roll over funds directly from an IRA to Delaware State University and avoid taxes on the funds you contribute. These contributions can be for any amount up to \$100,000 each year and can represent a significant form of annual tax savings.

### SETTING UP YOUR QUALIFIED CHARITABLE DISTRIBUTION
